FOR THE PROPOSED MARIHUANA CHARTER AMENDMENT

The following Resolution was offered by _____ with support from _____ to adopt the following resolution:

WHEREAS, an initiatory petition has been ordered on the ballot for the November 8, 2022 ballot by the Court of Appeals in an Opinion dated September 1, 2022; and

WHEREAS, as the City was just processing this petition and it believed it would not be on this year's ballot, the City did not prepare an explanatory caption to this proposal; and

WHEREAS, the City under Michigan statute MCL 117.21 may add an explanatory caption; and

WHEREAS, the City of the Village of Clarkston believes the initiative petition does not explain fully to the voters the parameters of this proposal. Therefore, the City authorizes and approves the following explanatory caption which would read as follows:

THEREFORE, IT IS RESOLVED

MEDICAL MARIHUANA PROPOSAL EXPLANATORY CAPTION

This amendment would authorize two (2) provisioning centers within the City and create regulations for the facilities by adding a new Chapter 16 to the City Charter.

Further, this provision would authorize marihuana facilities to operate between the hours of 9 AM to 9 PM Monday through Sunday. It would not permit recreational marihuana sales to any adult but does allow Commercial Medical Marihuana sales under the Medical Marihuana Facilities Licensing Act to qualified patients.
